The Office of the Defence Attaché, Embassy of Italy in New Delhi, hereby invites interested companies, authorised vehicle dismantlers, authorised recyclers, private person, scrap dealers and other eligible purchasers to submit a written financial offer for the purchase of the official vehicle described below.

- The vehicle is being offered for sale following the decision to replace the official vehicle.
- Prospective purchasers are advised to carry out their own inspection and assessment of the vehicle before submitting an offer.
- The purchaser shall be responsible for verifying, before purchase, all applicable requirements concerning registration, transfer, use, dismantling, recycling and/or disposal of the vehicle in Delhi/NCR and India.
- The vehicle is offered strictly on an "AS IS, WHERE IS" basis, without any warranty or guarantee as to its condition, performance or future road use.
- Any restrictions applicable to the circulation or registration of the vehicle shall be considered by the bidder when determining the amount offered.

3. INSPECTION OF THE VEHICLE

The vehicle may be inspected by prospective purchasers by prior appointment. Requests for inspection should be submitted to the Office of the Defence Attaché using the contact details indicated below.

4. SUBMISSION OF OFFERS

- Offers shall be submitted in writing, on the bidder's letterhead, and signed by the authorised representative.
- The offer shall clearly state the total purchase price proposed, in Indian Rupees (INR), inclusive of any applicable taxes, charges, transport, dismantling and other costs to be borne by the purchaser.
- The offer shall include the bidder's full legal name, registered address, contact person, telephone number, email address and, where applicable, details of the company's authorisation/licence for vehicle dismantling, recycling or scrap activities.
- The minimum bid is 85,000 INR
- Payment by bank transfer must be made within one week of the award.

5. DEADLINE AND METHOD OF SUBMISSION

Offers must be received no later than 05 october 2026 at 10:00 (IST). Offers may be submitted in sealed envelope to the following address:

The successful bidder shall make full payment of the agreed purchase price before the vehicle is handed over. Any costs arising from collection, transportation, transfer, dismantling, recycling, taxes, duties or other formalities shall be borne by the purchaser, unless otherwise expressly agreed in writing.
